

## Bicentennial Undergraduate Scholarship Endowed Fund Descriptions

### **Khan, Captain Humayun Memorial Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. First preference shall be given to students who are enrolled in the R.O.T.C. program. Second preference shall be given to students majoring in a field in which the United States Constitution and its history are a common area of focus, including, but not limited to, History and Political Science.

### **Sullivan, Sullivan and Douglas Laycock Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University.

### **White, Michael Bright Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to undergraduate students who demonstrate need as determined by the University. The Donors' preference is that the scholarship be awarded to a student who is deaf and/or to a student pursuing a degree that prepares her/him to work with deaf children; a second preference is that the scholarship be awarded to a student from Louisiana.

Qualified applicants will be determined by Student Financial Services. Award amounts will vary based on recipients' financial circumstances.

### **University Bicentennial Scholars Fund**

The income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need, as determined by the University. If the income cannot be used in any given year for the purpose specified here, it may be reinvested with the Fund corpus.

### **Street, Eugene K. Bicentennial Scholars Fund**

The income of the Fund shall be used to provide need-based scholarships to undergraduate students attending the College at Wise. The Donors' preference is that the scholarship be awarded to graduates of Buchanan County High Schools; a second preference is that the scholarship be awarded to students from southwest Virginia.

### **Price, Benjamin James and Michael Enoch Schimansky Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$50,000, the income of the Fund shall be used to provide need-based scholarships to worthy and deserving undergraduate students attending the College at Wise who demonstrate financial need as determined by the College at Wise Office of Financial Aid. Award amounts will vary based on recipients' financial circumstances. If the income cannot be used in any given year for the purpose specified here, it may be reinvested with the Fund corpus.

### **Thomas Family Bicentennial Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$50,000, the income of the Fund shall be used to provide need-based scholarships to worthy and deserving undergraduate students attending the College at Wise.

### **Sandridge, Leonard and Jerry Bicentennial Scholars Fund**

The income of the Fund shall be used to provide need-based scholarships to out-of-state undergraduate students who demonstrate financial need as determined by the University.

### **Egan, Robert J. and Leighanne M. Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University.

**Javor, Henry J. Bicentennial Scholars Fund**

The income of the Fund shall be used to provide need-based scholarships to undergraduate students enrolled at the School of Architecture who demonstrate financial need as determined by the University.

**Woodruff Family Squash Scholarship Fund**

The income of the Scholarship Fund shall be used to provide scholarships to student-athletes participating in the University's varsity squash program.

**Green, Phyllis A. & Don M. Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of Fifty Thousand Dollars (\$50,000), the income of the Fund shall be used to provide need-based scholarships to worthy and deserving undergraduate students attending the College at Wise.

**Elam, Lee and Jerroleen Bicentennial Scholars Fund**

The income of the Fund shall be used to provide need-based scholarships to worthy and deserving undergraduate students attending the College at Wise who demonstrate financial need as determined by the College at Wise Office of Financial Aid. The donor's preference is that the scholarship be awarded to students at the College at Wise participating in the men's and women's intercollegiate golf programs.

**Lee, Brenda B. and Lewey K. Lee Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$50,000, the income of the Fund shall be used to provide need-based scholarships to worthy and deserving undergraduate students attending the College at Wise.

**Prior, Merry Lu Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$50,000, the income of the Fund shall be used to provide need-based scholarships to worthy and deserving undergraduate students attending the College at Wise.

**Oldfield, Dona and Henry 2017 Bicentennial Scholars Fund**

The income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University.

**UVa-Wise Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of Fifty Thousand Dollars (\$50,000), the income of the Fund shall be used to provide need-based scholarships to worthy and deserving undergraduate students attending the College at Wise.

**Sheridan, Rachel Ward Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. The donor's preference is that the scholarship be awarded to a student who participates on one of the University's Track & Field teams; a second preference is that the scholarship be awarded to an Echols Scholar.

**Giza, Alexander & Cathy Noonan Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University.

It is the Donor's preference that the scholarships be awarded to students majoring in the Natural or Life Sciences, or Engineering.

**Durham-Rogers Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of Fifty Thousand Dollars (\$50,000), the income of the Fund shall be used to provide need-based scholarships to undergraduate students at Wise who demonstrate financial need as determined by the University.

The Donor's first preference is that the scholarship be awarded to students who reside in the Southwestern

region of the Commonwealth of Virginia. The Donor's second preference is for a student who demonstrated participation in athletics, the arts, or community service during their high school education.

**Nash, Mark T. and Sharon T. Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. The donor's preference is that the scholarship be awarded to students majoring in Accounting at the McIntire School of Commerce; a second preference is that the scholarship be awarded to students enrolled at the McIntire School of Commerce in any major.

**Outstanding Virginian Bicentennial Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. The donor's preference is that the scholarship be awarded to an exceptional student enrolled in the Frank Batten School of Leadership and Public Policy; a second preference is that the scholarship be awarded to a Virginian resident.

**Daniel Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of Fifty Thousand Dollars (\$50,000), the income of the Fund shall be used to provide need-based scholarships to undergraduate students at the College at Wise who demonstrate financial need as determined by the College at Wise Office of Financial Aid.

It is the Donor's preference that the scholarship be awarded to students at the College at Wise participating in scholarly research through the existing Fellowships in Natural Sciences (FINS) Program, with preference given to students majoring in Chemistry, then students majoring in the Natural Sciences.

**The Hilltop Foundation Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University.

**Street Bicentennial Scholars Fund**

The income of the Fund shall be used to provide need-based scholarships to worthy and deserving undergraduate students attending the College at Wise. It is the Donors' preference that the scholarship be awarded to students attending the College at Wise who are residents of Wise County or Buchanan County.

**Harker Family Bicentennial Scholars Fund**

The income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. It is the donor's preference that scholarships be awarded to students enrolled in the College of Arts & Sciences.

**Packer Family Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. It is the donor's preference that scholarships be awarded to students enrolled in the McIntire School of Commerce.

**Hawkins, McIntyre Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. The Donor's preference is that the scholarship be awarded to students who have graduated from a public high school.

**Heyer, Heather Memorial Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University.

#### **Fralin Family Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$500,000.00, the income of the Fund shall be used to provide scholarships to student-athletes at the University. It is the donor's preference that the scholarship be awarded to a student participating on the men's basketball team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

#### **O'Reilly, Jacqueline Endowed Athletics Scholarship**

When gifts to the Fund have met the minimum funding level of \$100,000.00, the income of the Fund shall be used to provide scholarships to student-athletes at the University. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

#### **Naughton, Timothy J. and Diane H. Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. The Donor's preference is that the scholarship be awarded to students enrolled in the College of Arts and Sciences; a second preference is that the scholarship be awarded to students who are residents of the Commonwealth of Virginia.

#### **Wilson, Danny E. Bicentennial Scholars Fund**

The income of the Fund shall be used to provide need-based scholarships to worthy and deserving undergraduate students attending the College at Wise. It is the Donor's preference that the scholarship be awarded to students attending the College at Wise who are residents of Wise County or Dickenson County, and who are coal miners or who come from families who walked in coal mining jobs.

#### **Driscoll, Lauren McGill Bicentennial Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. The Donor's preference is that the scholarship be awarded to students enrolled in the College of Arts and Sciences; a second preference is that the scholarship be awarded to students who reside outside the State of Virginia.

#### **Price, Diane Louise Bicentennial Scholars Fund**

The income of the Fund shall be used to provide need-based scholarships to worthy and deserving undergraduate students attending the College at Wise. It is the Donor's preference that the scholarship be awarded to students attending the College at Wise who live outside the Commonwealth of Virginia.

#### **Rogers Family Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$500,000.00, the income of the Fund shall be used to provide scholarships to student-athletes at the University. It is the Donor's preference that the scholarship be awarded to students participating on the men's basketball team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

#### **Clark Scholars Endowed Fund**

The University and the School of Engineering will use the Endowed Fund Gift solely to support the Clark Scholars Program as set forth in the agreement. See gift agreement for further restrictions on the Program.

#### **Luke, Douglas S. Family Scholarship for Men's Soccer**

When gifts to the Fund have met the minimum funding level of \$250,000.00, the income of the Fund shall be used to provide scholarships to student-athletes at the University. It is the Donor's preference that the scholarship be awarded to a student participating on the men's soccer team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

#### **Riley, Jonathan S. and Whitney E. Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. It is the Donor's preference that the scholarship be awarded to a resident of the

Commonwealth of Virginia; a second preference is that the scholarship be awarded to a student who graduated from a Virginia public high school.

**Fowler, F. Boyd Helping Hand Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$50,000, the income of the Fund shall be used to provide need-based scholarships to undergraduate students attending the College at Wise. The Donor's preference is that the scholarship be awarded to graduates of Buchanan County High Schools or to students from the designated distressed areas of Appalachia as reported by the Appalachian Regional Commission. The Donors also prefer, but do not require, that the scholarship be awarded to male students.

**Fowler, Gaynell S. Helping Hand Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$50,000, the income of the Fund shall be used to provide need-based scholarships to undergraduate students attending the College at Wise. The Donor's preference is that the scholarship be awarded to graduates of Buchanan County High Schools or to students from the designated distressed areas of Appalachia as reported by the Appalachian Regional Commission. The Donors also prefer, but do not require, that the scholarship be awarded to female students.

**McReynolds, Dorothy Couch, Jerroleen Couch Elam, and Mildred Couch Bicentennial Scholars Fund**

The income of the Fund shall be used to provide need-based scholarships to worthy and deserving undergraduate students attending the College at Wise. It is the Donor's preference that the scholarship be awarded to students who are pursuing the Bachelor of Science in Nursing Degree; a second preference is that the scholarship be awarded to students who are residents of Castlewood or Russell County, Virginia.

**Grant, Peter M. II Family Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$500,000.00, the income of the Fund shall be used to provide scholarships to student-athletes at the University. It is the Donor's preference that the scholarship be awarded to a student participating on the men's basketball team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

**Home Paddocks Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University.

**Elam, Jerroleen and Lee Bicentennial Scholars Fund**

The income of the Fund shall be used to provide need-based scholarships to worthy and deserving undergraduate students attending the College at Wise. It is the Donor's preference that the scholarship be awarded to students attending the College at Wise who are graduates of Castlewood High School in Castlewood, Virginia. If the high school ceases to exist, preference will be given to students who live within the service area of Castlewood High School.

**Kreisa, Ron and Sue Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$250,000.00, the income of the Fund shall be used to provide scholarships to student-athletes at the University. It is the Donor's preference that the scholarship be awarded to a student participating on the men's basketball or baseball team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

**England, Nick Foundation Bicentennial Scholars Fund**

The income of the Fund shall be used to provide need-based scholarships to worthy and deserving undergraduate students attending the College at Wise. The Nick England Foundation Scholarship will be awarded to student leaders who graduate from high schools located in Southwest Virginia. Leadership will be evidenced by involvement in the community and demonstrated commitment to academic pursuit, faith, family and community services. Recipients will maintain a minimum 3.0 grade point average.

#### **Perkins, Rhonda M. and Scott Bicentennial Scholars Fund**

The income of the Fund shall be used to provide need-based scholarships to worthy and deserving undergraduate students attending the College at Wise. It is the Donor's preference that the scholarship be awarded to students attending the College at Wise who graduated from high schools located in southwest Virginia; a second preference is that the scholarship be awarded to students who are participating in intercollegiate athletics, with first priority for students participating on the football team.

#### **Reyes Family Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University.

#### **Yates Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. The Donor's preference is that the scholarship be awarded to students enrolled in the College of Arts & Sciences as History majors; a second preference is that the scholarship be awarded to students who are residents of the Commonwealth of Virginia.

#### **Knox, John R. and Alexandra S. Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. The Donor's preference is that the scholarship be awarded to students who are residents of Delaware; a second preference is that the scholarship be awarded to students enrolled in the School of Engineering and Applied Science.

#### **Hamilton, Alex and Berno Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University.

#### **Mangas, Allison C. and Thomas B. Family Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need. It is the donor's preference that scholarship recipients be residents of rural communities or outside of major cities in the Midwest or Appalachian regions, as determined by the University.

#### **Parkansky, Kathleen W. RN, BSN, Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$200,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University.

The donors' preference is that the scholarship be awarded to a student in the School of Nursing who is enrolled in the BSN program or the RN to BSN program.

#### **Poole Family Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. If the income cannot be used in any given year for the purpose specified here, it may be reinvested with the Fund corpus.

#### **Booth, Richard L. and Roxanne R. Bicentennial Scholars Fund**

When contributions to the Fund have met the minimum funding level of \$500,000.00, the income of the Fund shall be used to provide two separate scholarships to student-athletes at the University: the Craig K. Littlepage Bicentennial Scholarship and the Margaret Littlepage Bicentennial Scholarship. It is the Donor's preference that the Craig K. Littlepage Bicentennial Scholarship be awarded to students participating on the men's basketball team. The Margaret Littlepage Bicentennial Scholarship shall be awarded to student-athletes

without a preference for a particular team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

**Geismar, Michael S. and Ellen A. Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$500,000.00, the income of the Fund shall be used to provide scholarships to student-athletes at the University. It is the Donor's preference that the scholarship be awarded to a student participating on the women's lacrosse team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

**Fassio, Danny Lee Family Bicentennial Scholars Fund**

When contributions to the Fund have met the minimum funding level of \$500,000.00, the income of the Fund shall be used to provide scholarships to student-athletes at the University. It is the Donor's preference that the scholarship be awarded to a student participating on the football team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

**Dudley, Victoria Atwill Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. The Donor's preference is that the scholarship be awarded to students who are Pell Grant eligible, or eligible for any successor program should the Pell Grant program end. A second preference is that the scholarship be awarded to students who are residents of the Commonwealth of Virginia.

**Uva College at Wise - Carl W. Smith Bicentennial Scholars Fund**

The income of the Fund shall be used to provide scholarships to worthy and deserving qualified undergraduate students attending Uva-Wise who are eligible for the Wise Scholars Program and the Chancellor's Scholars Program, and who are U.S. Citizens or Lawful Permanent Residents (as hereinafter defined) and residents of the Commonwealth of Virginia; provided, however, preference shall be given to U.S. Citizens. For the purposes of this Agreement, Lawful Permanent Residents are defined as individuals who have attained the status as lawfully admitted for permanent residence in the United States as defined in section 101(a)(20) of the Immigration and Nationality Act, 8 U.S.C. sections 1101(a)(20).

The description and criteria for the Wise Scholars Program and the Chancellor's Scholars Program, allocation of annual scholarships to be awarded for these programs, and counties and cities with the Commonwealth of Virginia for which the Wise Scholars Program has a priority, are provided in Appendix A: (see complete agreement)

**Uva College at Wise - Carl. W. Smith Bicentennial Scholar-Athlete Fund**

The income of the Fund shall be used to provide scholarships to worthy and deserving qualified undergraduate students attending Uva-Wise who are eligible for the Scholar-Athlete Program. The criteria for this scholarship is provided in Appendix A: (see complete agreement)

**Lewis, Lemuel E. and Sandra Wicks Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$1,000,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University.

In addition to providing need-based scholarships to undergraduate students who demonstrate financial need, the Donors prefer, but do not require, that the scholarship be awarded to under-represented undergraduate students enrolled in the College of Arts and Sciences. The scholarships are intended to benefit more than one undergraduate student (incoming, returning, or transfer). It is the Donors' intent that no more than 10% of the income of the Fund shall be used to provide a scholarship to any one student per year.

**Lewis, Lemuel E. and Sandra Wicks Bicentennial Scholars Fund #2**

When gifts to the Fund have met the minimum funding level of \$300,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University.

#### **Gilliam, Marcia Adams Bicentennial Scholars Fund**

The income of the Fund shall be used to provide need-based scholarships to worthy and deserving undergraduate students attending the College at Wise. It is the Donor's preference that the scholarship be awarded to students attending the College at Wise who participate on the Women's Tennis Team. The Donor's second preference is that the scholarship be awarded to participants of the Men's Tennis Team.

#### **Wise, Henry A. II, MD Bicentennial Scholars Fund in Honor of Coach Frank W. Finger**

When contributions to the Fund have met the minimum funding level of \$500,000.00, the income of the Fund shall be used to provide scholarships to student-athletes at the University. It is the Donor's preference that the scholarship be awarded to a student participating on the wrestling team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

#### **Epps, John and Patricia Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. The Donor's preference is that the scholarship be awarded to students enrolled in the College of Arts & Sciences.

#### **Owen Family Bicentennial Scholars Fund**

The income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. It is the Donor's preference that scholarships be awarded to students enrolled in the School of Engineering from underserved populations. The University will define "underserved" to include a broad spectrum of students from backgrounds that currently lag behind in access to higher education in engineering and STEM fields.

#### **Strickler, Leroy and Betty Bicentennial Scholars Fund**

When contributions to the Fund have met the minimum funding level of \$500,250.00, the income of the Fund shall be used to provide scholarships to student-athletes at the University. It is the Donors' preference that the scholarship be awarded to a student participating on the women's basketball team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

#### **Horn Family Bicentennial Scholars Fund**

The income of the Fund shall be used to provide need-based scholarships to undergraduate students attending the College at Wise. It is the Donor's preference that scholarships be awarded to students from southwest Virginia who are majoring in science.

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to student-athletes at the University. It is the Donor's preference that the scholarship be awarded to a student participating on the Women's Swimming & Diving Team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.



#### **Ledford Family Bicentennial Scholars Fund**

When contributions to the Fund have met the minimum funding level of \$500,000, the income of the Fund shall be used to provide scholarships to student-athletes at the University. It is the Donor's preference that scholarships be awarded to students participating on the men's basketball team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

#### **King, William L. and Elaine S. Scholarship Fund**

The income of the Fund (income only) shall be used to provide need-based scholarships to undergraduate students enrolled in Arts and Sciences who demonstrate financial need as determined by the University.

#### **Kapadia Family Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. It is the Donor's preference that the scholarship be awarded to first generation college students.

#### **Lampkin, Patricia M. and Wayne D. Cozart Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. The Donor's preference is that the scholarship be awarded to students who have "Independent Student Status" per the federal student aid regulations.

When gifts and University match contributions to the Fund have met the minimum funding level of \$500,000, the income of the Fund shall be used to provide scholarships to student-athletes at the University. It is the Donor's preference that the scholarship be awarded to a student participating on the football team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

#### **Greenhouse Family Bicentennial Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University.

#### **Gott, Jim and Eva Bicentennial Scholars Fund**

The income of the Fund shall be used to provide need-based scholarships to worthy and deserving undergraduate students attending the College at Wise. It is the Donors' preference that scholarships be awarded to students attending the College at Wise who have distinguished themselves as leaders or have demonstrated a commitment to community service, and who show promise for academic success. scholarships to students attending the College at Wise.

#### **Odrich Family Bicentennial Scholars Fund**

If and when grants or gifts to the Fund have met the minimum funding level of \$100,000.00, the income from the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. The Donors' preference is that the scholarship be awarded to students enrolled in the College of Arts and Sciences.

#### **Phi Gamma Delta Karl Belczyk Memorial Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000.00, the income from the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. It is preferred that the scholarship be awarded to a member of the Phi Gamma Delta fraternity; a second preference is that the scholarship be awarded to a student enrolled at the School.

#### **LLF Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000.00, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. It is the Donor's preference that scholarships be awarded to students who are residents of Virginia and are enrolled in the College of Arts & Sciences.

#### **Eli Banana Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. The Donor's preference is that the scholarship be awarded to a fraternity member; a second preference is that the scholarship be awarded to a fourth-year student. #### **Bright Family Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide need-based scholarships to students who demonstrate financial need as determined by the University.

It is the Donors' preference that when a school of data science (the "School") has opened at the University and when undergraduate enrollment for the School has been approved and/or when undergraduates begin to matriculate in the School, scholarships be awarded to undergraduate students enrolled in the School. It is the Donors' preference that the scholarship be awarded to an incoming first-year student enrolled in the School, and that the scholarship be awarded to the same student each of the following years until the student graduates, provided that student maintains eligibility requirements. If Fund income is sufficient to support more than one scholarship, the Donors prefer that each additional scholarship be awarded to an incoming first-year student enrolled in the School and awarded to the same student each of the following years until the student graduates, provided eligibility requirements are maintained.

#### **Holliday Family New York Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the College Foundation), the income from the Fund shall be distributed to Student Financial Services on a semi-annual basis and used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. Scholarship recipients shall be selected by Student Financial Services.



It is the Donor's preference that scholarships be awarded to students from New York State whose academic credentials have earned them admission to the University of Virginia College of Arts & Sciences; these recipients will be known as Holliday Family New York Bicentennial Scholars.

#### **Ducharme Family Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to student-athletes at the University. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

It is the Donors' preference that scholarships be awarded to students who maintain a grade point average of at least 3.0; a second preference is that scholarships be awarded to students who demonstrate a determined work ethic, integrity, and sportsmanship - as determined by coaches, administrators and/or staff - that distinguishes the student from his/her peers.

#### **Stein, Brett A. Memorial Bicentennial Scholars Fund**

When the Donors' gifts to the Fund, together with other pledged commitments to the Funds, have met the minimum funding level of \$100,000 (at the College Foundation), the Fund will be considered eligible for distributions. It is the Donor's preference that scholarships be awarded to students who are residents of the state of South Carolina or the state of Georgia.

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University.

#### **Eston Hemings Jefferson Bicentennial Scholars Quasi-Endowment Fund**

The income from this quasi will be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University. It is the department of Music's preference that scholarships be awarded to under-represented undergraduate students who score highly on their arts supplements in Music. Student Financial Services will manage the Fund and determine scholarship recipients.

#### **Cook Family Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the College Foundation), the Fund will be considered eligible for distributions (income). The Income of the Fund shall be distributed to the University's Office of Student Financial Services on a semi-annual basis and used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by Student Financial Services. Scholarship recipients shall be selected by Student Financial Services. It is the Donors' preference that scholarships be awarded to students enrolled in Arts & Sciences.

#### **Rodriguez Family Bicentennial Scholars Fund**

When gifts and University match contributions to the Fund have met the minimum funding level of \$250,000, the income of the Fund shall be used to provide scholarship support to a student-athlete at the University. It is the Donor's preference that the scholarship be awarded to an in-state student-athlete in the College of Arts and Sciences majoring in Economics; a second preference is that the scholarship be awarded to an in-state student-athlete majoring in another program in the College of Arts and Sciences. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

#### **Fletcher, G. Richard, Jr. Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the Fund will be considered eligible for distribution (Income). The Income of the Fund shall be used to provide scholarships to student-athletes at the University. It is the Donor's preference that the scholarship be awarded to a student participating on the baseball team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

#### **Global Experience Bicentennial Scholars in Arts & Sciences Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the College Foundation), the Fund will be considered eligible for distributions (Income). The Income of the Fund shall be distributed to the University's Office of Student Financial Services on a semi-annual basis and used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by Student Financial Services. Scholarship recipients shall be selected by Student Financial Services.

If one or more recipients are selected for scholarships according to the Donor's preference and there are remaining funds available, or if the Donor's preferences cannot be met in any given year because no students who meet the preferred criteria can be identified, the Income may be used to provide general need-based scholarships.

#### **Luda Angeline Hope Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$50,000 (at the UVA Wise Fdn), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the College at Wise Office of Financial Aid.

In an effort to make higher education more accessible, the Donor prefers, but does not require, that scholarships supported by the Fund be awarded first to students who are non-traditional females who are pursuing a college degree at the College at Wise.

#### **Brown, Amy and Kevin Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the McIntire Fdn), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be distributed to the University's Office of Student Financial Services consistent with a mutually agreed upon schedule approved by Student Financial Services and the Foundation and used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by Student Financial Services. Scholarship recipients shall be selected by Student Financial Services.

It is the Donors' preference that scholarships be awarded to students in the McIntire School of Commerce; a second preference is that scholarship be awarded to first-generation college students.

#### **Quillen, Jennifer Lockhart Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$50,000 (at the UVA Wise Fdn), the Fund will be considered eligible for distributions ("Income"). The income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the UVA Wise Office of Financial Aid.

It is the Donors' preference that scholarships be awarded to students who have graduated from schools in Scott County, Virginia or Dickenson County, Virginia.

#### **Poulson, Richard J. M. Scholarship Fund JSF**

Once the minimum funding level of \$100,000 has been met at the Jefferson Scholars Foundation, the Income of the fund will be used to provide Walentas Scholarships to deserving first generation undergraduate students

at the University of Virginia and to support the Walentas Scholarship Program's effort to recruit outstanding students. These scholarships shall be awarded according to the established criteria and selection process of the Foundation with preference given to students from Los Angeles, California. This scholarship shall be governed by the provisions of a MOU executed on March 10, 2022 between the Jefferson Scholars Foundation and the University.

**Lambert, Michael "Bert" Bicentennial Scholarship in Business Fund**

The income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the College at Wise Office of Financial Aid.

It is the Donor's preference that the Income be used to provide scholarships to students pursuing a degree in business or a business-related field.

**Napoleon Hill Foundation Keys to Success Bicentennial Scholarship Fund**

The income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the College at Wise Office of Financial Aid.

It is the Donor's preference that scholarships be awarded to students who have distinguished themselves as leaders, enrolled in Keys to Success or having been selected for membership in the Napoleon Hill Scholars Program at the College at Wise. I

**VanGundy, Amelia and Bob Bicentennial Scholarship in Earth and Physical Sciences Fund**

The income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the College at Wise Office of Financial Aid.

It is the Donor's preference that the Income be used to provide scholarships to students of underrepresented populations pursuing a degree in the fields of Earth or Physical Sciences.

**Trapnell Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University's Office of Student Financial Services. Scholarship recipients shall be selected by Student Financial Services.

**Davis, Shelby and Kathryn Bicentennial Scholarship**

When gifts to the Fund have met the minimum funding level of \$100,000, the fund will be considered eligible for distributions. The distributions would first provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University's Office of Student Financial Services. Scholarship recipients shall be selected by Student Financial Services. Preference should be given to first-generation college students.

**Barr Family Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the McIntire Fdn), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by Student Financial Services. Scholarship recipients shall be selected by Student Financial Services.

It is the Donors' preference that scholarships be awarded to students enrolled in McIntire.

**Sheridan Family Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$500,000, the Fund will be considered eligible for distributions (Income). It is the Donor's preference that the Income of the Fund shall be used to provide scholarships to student-athletes participating on the women's track and field/cross country team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

**Coogan, H. William Jr. Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the Fund will be considered eligible for distributions (Income). The Income of the Fund shall be used to provide scholarships to student-athletes at the University. It is the donor's preference that the scholarship be awarded to a student participating on the

varsity baseball team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

**Loverro, Francis J. and Kristina R. Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the College Fdn), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be distributed to the University's Office of Student Financial Services on an annual basis and used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by Student Financial Services. It is the Donors' preference that scholarships be awarded to students enrolled in Arts & Sciences.

**Todorovich Family Global Experience Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University's Office of Student Financial Services.

It is the Donors' preference that scholarships be awarded to students pursuing a credit-bearing international experience through UVA, including the summer term. Recipients will be selected by the University's International Studies Office in coordination with the University's Office of Student Financial Services.

**Scott, Karren E. Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the College Fdn), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be distributed to the University's Office of Student Financial Services on an annual basis and used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by Student Financial Services.

It is the Donor's preference that scholarships be awarded to undergraduate students enrolled in Arts & Sciences. It is the Donor's second preference that the scholarship be awarded to First-Generation college students.

**Scott, Karren E. Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the College Fdn), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be distributed to the University's Office of Student Financial Services on an annual basis and used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by Student Financial Services.

It is the Donor's preference that scholarships be awarded to undergraduate students enrolled in Arts & Sciences. It is the Donor's second preference that the scholarship be awarded to First-Generation college students.

**Neblett Family Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the College Fdn), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be distributed to the University's Office of Student Financial Services on an annual basis and used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by Student Financial Services.

It is the Donors' preference that scholarships be awarded to undergraduate students enrolled in Arts & Sciences.

**Northern Virginia/Washington DC Walentas Scholarship Fund JSF**

The Scholarship Fund shall be used to provide Walentas Scholarships to deserving first generation undergraduate students at the University of Virginia and to support the Walentas Scholarship Program's effort to recruit outstanding students. These scholarships shall be awarded according to the established criteria and selection process of the Foundation with preference given to students from Northern Virginia and Washington, D.C.

**Doherty, Karen Donckers Bicentennial Scholars Fund for Nursing**

When contributions to the Fund have met the minimum funding level of \$100,000 (at the UVA Health Foundation), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be distributed to the University's Office of Student Financial Services consistent with a mutually agreed upon schedule approved by Student Financial Services and the Foundation used to provide need-based scholarships

to undergraduate students who demonstrate financial need as determined by Student Financial Services.

Scholarship recipients shall be selected by Student Financial Services. It is the Donor's preference that scholarships be awarded to pre-licensure students enrolled in the School of Nursing; a second preference is that the recipient, or their parents, be veterans or active service members of the United States Armed Forces.

#### **Mazahery-Sayah Family Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the College Foundation) the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be distributed to the

University's Office of Student Financial Services on an annual basis and used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by Student Financial Services. It is the Donors' preference that scholarships be awarded to undergraduate students enrolled in Arts & Sciences; a second preference is that scholarships be awarded to students who are from underrepresented populations at the University. Student Financial Services will define "underrepresented" to include a broad spectrum of students from diverse environments that currently lag behind in access to higher education. As first-generation United States citizens, Drs. Mazahery and Sayah are establishing this scholarship to support students with similar backgrounds to their own.

#### **Love, Kim and Mary Kay Scholarship Fund JSF**

The gift will establish the Kim and Mary Kay Love Scholarships. In the awarding of these scholarships, preference will be given to students with demonstrated financial need who were nominated to, and unsuccessful in, the Foundation's Jefferson or Walentas Scholarship competitions. Demonstrated financial need shall be determined by the University's Office of Student Financial Services ("SFS"). Scholarship recipients shall be selected by the Foundation in coordination with SFS.

#### **Summerville Family McIntire Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University's Office of Student Financial Services. Scholarship recipients shall be selected by Student Financial Services. It is the Donors' preference that scholarships be awarded to students enrolled in the McIntire School of Commerce.

#### **Freeman, Christopher D.W. and Patsy F. Robinson Family Bicentennial Fund**

The Income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the College at Wise Office of Financial Aid. It is the donor's preference that the income be used to provide scholarships to students who reside in the footprint of what was the service area of Coeburn High School, now a combined school named Eastside high School.

#### **Tara Carr Snyder & Ben Carr Softball Bicentennial Scholars Fund**

The income of the Fund shall be used to provide scholarships to student-athletes at the University. It is the Donors' preference that the scholarship be awarded to a student participating on the Women's Softball team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

#### **Driscoll, John and 1980 Team Legacy Bicentennial Scholars Fund**

Once gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to student-athletes. It is the Donor's preference that the scholarship be awarded to a student participating on the Men's Lacrosse team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

#### **Harry, Frederick P., Jr. Memorial Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the Income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University's Office of Student Financial Services. Scholarship recipients shall be selected by Student Financial Services.

It is the Donor's preference that scholarships be awarded to students from the Tri-Cities region of Virginia, defined as the cities of Petersburg, Colonial Heights, and Hopewell and the adjoining counties of Chesterfield,

Dinwiddie, and Prince George; a second preference is that scholarships be awarded to students majoring in Chemical Engineering.

**Jain, Sucheta Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the Income of the Fund shall be used to provide need-based scholarships to undergraduate students who demonstrate financial need as determined by the University's Office of Student Financial Services. Scholarship recipients shall be selected by Student Financial Services.

It is the Donors' preference that scholarships be awarded to undergraduate students enrolled in the McIntire School of Commerce; a second preference is that scholarships be awarded to students from the Commonwealth of Virginia.

**Starsia, Dom Bicentennial Scholars Fund**

When gifts to the fund have met the minimum funding level of \$100,000, the income shall be used to provide scholarships to student-athletes at the University. It is the Donor's preference that the scholarship be awarded to a student participating on the Men's Lacrosse team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.

**Class of 1991 Virginia Men's Lacrosse Bicentennial Scholars Fund**

When gifts to the fund have met the minimum funding level of \$100,000, the income shall be used to provide scholarships to student-athletes at the University. It is the Donor's preference that the scholarship be awarded to a student participating on the Men's Lacrosse team. The scholarship selection process shall be managed by the Virginia Athletics Foundation in consultation with the Director of Athletics.



## Bicentennial Graduate Endowed Fund Descriptions

### **Proctor, George Louis Bicentennial Fellows Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, Fund income shall be used to provide fellowships to graduate students pursuing a doctoral degree in the field of philosophy. The Donor wishes to state her preferences, but understands Arts & Sciences will select the best candidate for the fellowship, regardless of her preferences. The Donors' preferences are that the fellowship recipients are male and residents of the Commonwealth of Virginia.

This gift is in memory of Mr. George Louis Proctor who was proud of his University of Virginia education and the values and ideals it represented to him. George spoke highly of the young men that were educated in Charlottesville, the honor system, and the University as a special place in higher education. The Donor's gift is in Mr. Proctor's honor to memorialize his special relationship with the University and to fulfill his desire to support graduate students in philosophy and in gratitude of the scholarship he received while attending the University.

### **Karsh, Martha Lubin and Bruce A. Karsh Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to graduate students in the School of Law.

### **Callahan, Carolyn M. and Michael S. Caldwell Bicentennial Scholars Fund**

The income of the Fund, but none of the principal, shall be used to provide fellowships to graduate students in the Curry School who are pursuing a doctoral program of study in the area of the education and development of gifted students. It is the Donors' preference, but not requirement, that this Fellowship be awarded to a female doctoral student. Awards shall be used to support graduate assistant wages and tuition and fees.

### **Batten Bicentennial Fellowships in Early Childhood Education Fund**

When gifts to the Fund have met the minimum funding level of \$1,000,000 (at the Curry School Foundation), the Fellowship Fund will be considered eligible for distributions (Income). The Income of the Fellowship Fund shall be used to provide two training fellowships in early childhood education research and development at the School.

### **Batten Family Bicentennial Scholars Fund**

The income of the Fund shall be used to provide fellowships to graduate students in the Batten School.

### **Hogge, Joan S. and W. Allen Medical Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to students in the School of Medicine.

### **Kington Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to graduate students in the School (Darden).

The Donor requires that recipients of the scholarship demonstrate financial need, and must have been born or must currently be a resident of a county included in the United States Government's Appalachian Region within the states of Virginia, West Virginia or Tennessee.

The Donor agrees that up to five percent of the income of the Fund may be used for the purposes of promoting the scholarship and attracting applicants from the identified region of the country.

### **Coleman Family Medical Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$250,000, the income of the Fund shall be used to provide scholarship to students in the School of Medicine.

### **Page, Dr. Gene R. & David H. White PhD Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to graduate students in the School (Darden).

The Donors' order of preference for awarding the scholarship is: 1. Has a connection to Memphis, Tennessee and/or Birmingham, Alabama. 2. Has a connection to Tennessee and/or Alabama. 3. Holds an undergraduate degree in Liberal Arts. 4. Has worked in finance.

The Donors prefer that recipients of the scholarship meet as many of these criteria as possible.

**Thompson, Warren M. Scholarship Fund**

The Fund will be used to support students at the School (Darden). The Donor prefers that scholarships supported by the Fund be awarded to Students enrolled in the Darden School of Business who have demonstrated a commitment to diversity.

**Meyer, Elizabeth K. Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide fellowships to graduate students in the Department of Landscape Architecture at the Architecture School.

**Copenhaver Charitable Trust Bicentennial Fellows Fund**

The income of the Fellowship Fund shall be used to provide fellowships to graduate students enrolled in the School (Engineering).

**Bugas Family Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to graduate students in the School (Darden).

**Batten Foundation Darden Worldwide Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide Darden Worldwide scholarships to graduate students in the School (Darden). It is the intent of the Donor to try to enable each Darden residential MBA student to have a least one global experience while studying at Darden.

If the income cannot be used in any given year for the purpose specified here, it may be used to award need-based scholarships for MBA students at the School (Darden).

**Lewis, Lemuel E. Bicentennial Scholars Fund for Global Leadership**

The Fund will be used to support students at the School (Darden) who demonstrate, promote and foster a global perspective and deep understanding of other beliefs and cultures including the religious, political, economic and social context in which they exist. The Fund will support the following purposes:

1. Second Year Award: Up to one half of the available funds each year, not to exceed the full cost of tuition, should be made available and awarded to a Second Year student(s) at the School who have demonstrated interests and activities to increase inclusiveness among various economic, political, religious and social groups. A selection committee that includes the student affinity club leaders and involves a select group of faculty and staff will review and select nominees.
2. Scholarships: Remaining funds will be used to provide a First Year scholarship for graduate students in the School who have demonstrated interests and activities to increase inclusiveness among various economic, political, religious and social groups. A selection committee that includes the student affinity club leaders and involves a select group of faculty and staff will review and select nominees.

**School of Education Parents Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund, shall be used to provide fellowships to Master of Teaching graduate students in the Curry School.

**Balog Bicentennial Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to graduate students in the School (Darden).

#### **Yuyan Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be combined with the Yuyan Scholarship Fund held by the Darden School Foundation to award scholarships to graduate students at the School (Darden). Scholarships shall be awarded at a minimum of a one-third tuition level. As earnings allow, scholarships may be awarded at levels above one-third tuition.

The Donors will designate preferences for scholarship recipients at a future date.

#### **WW Yen Bicentennial Future Year Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to students with an undergraduate degree from the University of Virginia who are enrolled through the Darden Future Year Scholars Program. Scholarships may also be provided to students enrolled through the Darden Future Year Scholars Program who are proficient in the Chinese language.

#### **Lebda Family Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to graduate students in the School (Darden). Scholarships shall be awarded in the following order of Donor preference: 1. First Donor Preference: Admitted students with demonstrated financial need. 2. Second donor preference: Admitted students.

If the income cannot be used in any given year for the purpose specified here, it may be reinvested with the Fund corpus.

#### **Hund-Mejean Family Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to graduate students in the School (Darden). The Donors' first preference is that the scholarships be awarded to international students proficient in German. The Donors' second preference is that the scholarships be awarded to international students proficient in at least one official language of the European Union in addition to English.

#### **Herman, Leslie S. Bicentennial Fellows Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide fellowships to graduate students specializing in architectural history/theory in the Ph.D. program in The Constructed Environment at the Architecture School.

#### **Ohslund, Dr. Ron (Capt., M.C., U.S.N., Ret.) Medical Bicentennial Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to students in the School of Medicine with preference given to a student from either a Navy and/or Marine Corps active duty or retired family. Secondary preference will be given to a student from an active duty or retired US military family.

#### **Strangfeld Military Scholarship Fund**

The income of the Fund shall be used to annually provide 2 two-year half-tuition scholarships to graduate students in the School (Darden) who are military veterans, and a greater number than two scholarships when investment results warrant.

#### **Shen Family Resident Education Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide educational funds, such as research, seminar, and conference funding, for School of Medicine residents in the Department of Orthopaedics.

#### **Newton, Professor Derek A. Bicentennial Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to graduate students in the School (Darden).

#### **Global Development Studies Masters in Commerce Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to deserving student(s) accepted into the M.S. in Commerce Program at the McIntire School of Commerce based on the following preferences: 1st preference – A student who graduated from the College of Arts & Sciences at the University of Virginia and participated in the College's Global Development Studies Program. 2nd preference – A student who graduated from the College of Arts & Sciences at the University of Virginia. .

#### **Morelli, Joseph James Bicentennial Graduate Fellows Fund**

Distributions from the Fund will commence when gifts and University contributions to the Fund have met the minimum funding level of \$500,000. The income of the Fund shall be used to provide fellowships to doctoral students for study and research in the areas of dyslexia, dyscalculia, and dysgraphia in the Curry School.

#### **Henderson, Mary M. and Charles H., III Medical Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (Medical School Foundation), the income of the Fund shall be used to provide scholarships to students in the School of Medicine.

#### **Henderson, Mary M. and Charles H., III MD/MS Dual Degree Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (Medical School Foundation), the income of the Fund shall be used to provide scholarships to students in the MD/MS Dual Degree Program, a program created by the School of Medicine in combination with the McIntire School of Commerce.

#### **Weinberg, Carroll A. Medical Bicentennial Scholars Fund**

The income of the Fund shall be used to provide scholarships to students in the School of Medicine.

#### **Burnet, A. Hazen and Sarah M. Military Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund will be pooled with other such resources to provide scholarships to graduate students in the School (Darden). The Donors' preference is that the scholarships be awarded to students enrolled in the residential School MBA program who are (former and/or current) active duty United States military, reserve United States military, honorably discharged United States military or retired United States military members (or similar categories of National Guard or State Militias).

#### **Class of 1989 Bicentennial Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to graduate students in the School (Darden). The Donors' preference is that the scholarships be awarded to students with demonstrated financial need.

#### **Coogan Family Bicentennial Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to graduate students in the School's (Darden) residential MBA program.

#### **Class of 1994 Michael D. Traina Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to graduate students in the School's (Darden) with demonstrated financial need.

#### **Graebner, Norman A. Bicentennial Fellows Fund**

When gifts to the Fund have met the minimum funding level (\$200,000 at the Law Foundation), income from the Fund shall be used to provide a scholarships to students in the Law School.

**Friedman, Catherine J. and Duane Family Bicentennial Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to graduate students in the School (Darden).

When gifts to the Fund have met the minimum funding level of \$100,000 (at the Med School Fdn), the income of the Fund shall be used to provide scholarships to students in the School of Medicine.

**Dell Family Bicentennial Scholars Fund Honoring John C. Jeffries, Jr. and Paul G. Mahoney**

When principal gifts to the Fund have met the minimum funding level of \$166,670 (at the Law Foundation), the income of the Fund shall be used to provide scholarships to Law School students with demonstrated financial need, as determined by the Law School's Office of Financial Aid. It is the Donor's preference that

scholarships be awarded first to Yale undergraduate alumni, and second, to University of Virginia undergraduate alumni. The Law School will make every reasonable effort to accommodate these preferences.

#### **Ross, David and Laura Bicentennial Grand Challenge Fellowship**

When gifts to the Fellowship Fund have met the minimum funding level of \$600,000 (at the College Foundation), distributions of income from the Fellowship Fund, together with income from the matching fund held by the University, shall be used to provide a fellowship to graduate students enrolled in the Graduate School of Arts & Sciences whose field of research is one of Arts & Sciences' strategic priorities, as determined by the Dean of Arts & Sciences.

When gifts to the Fund have met the minimum funding level of \$100,000 (at the Med School Fdn), the income of the Fund shall be used to provide scholarships to students in the School of Medicine.

#### **Class of 1986 Peter J. Niehaus Memorial Bicentennial Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the Fund will be considered eligible for distributions. The income of the Fund shall be combined with income from the Class of 1986 Peter J. Niehaus Memorial Scholarship Fund, an existing fund held at the Darden School Foundation, to provide scholarships to graduate students enrolled in the School.

It is the Donor's preference that scholarships be awarded to students based on the following award criteria:

**Ring, Renee E. '76 Bicentennial Scholars Fund**

When gifts (at the Law School Foundation) to the Fund have met the minimum funding level of \$166,667, the Fund will be considered eligible for distributions. The income of the Fund shall be used to provide scholarships to J.D. degree candidates enrolled in the Law School.

**Nelson, L. Paul II and Family Scholarship Fund**

The income of the Fund shall be used to provide scholarships to graduate students at the Darden School.

**Giovine, Elisabeth Morse Design Excellence Bicentennial Fellowship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the Fund will be considered eligible for distributions. The income of the Fund shall be used to provide fellowships to graduate students in the Architecture School. It is the Donors' preference that fellowships be awarded to students pursuing graduate studies in design in architecture, landscape architecture, or urban design.

**Fultz, Darren A. Bicentennial Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the income of the Fund shall be used to provide scholarships to graduate students in the School (Darden). It is the Donor's preference that the scholarship be awarded to students with demonstrated financial need.

It is the Donor's preference that the scholarship be awarded to students with demonstrated financial need.

**DeCola, Mike and Lee Family Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the Fund will be considered eligible for distributions (Income). The income of the Fund shall be combined with income from the Mike and Lee DeCola Family Scholarship Fund, held at the Darden School Foundation, to provide financial support for residential MBA students at the Darden School of Business, with a preference for those who have backgrounds in manufacturing organizations.

If the income cannot be used in any given year for the purpose specified here, it may be reinvested.

When gifts to the Fund have met the minimum funding level of \$100,000 (at the Med School Fdn), the Fund will be considered eligible for distributions (Income).

#### **Wimbush, F. Blair Bicentennial Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$166,667 (at the Law School Fdn), the Fund will be considered eligible for distributions (Income). The Income of the Fund shall be used to provide scholarships to J.D. degree candidates enrolled in the Law School, with a preference for students who demonstrate financial need and/or students who would support the Law School's educational mission and goal of promoting a diverse student body. The Income of the Fund shall be used to provide scholarships/fellowships to graduate students enrolled in the School of Engineering. These fellowships will be awarded at the discretion of the Department Chair of the Department of Materials Science and Engineering, with the approval of the Dean of the School of Engineering, to graduate students in the Department of Materials Science and Engineering within the School of Engineering.

The Income of the Fund shall be used to provide scholarships to graduate students enrolled in the School of Medicine. If the income cannot be used in any given year for the purpose specified here, it may be reinvested with the Fund corpus.

The Income of the Fund shall be used to provide scholarships to J.D. degree candidates enrolled in the University of Virginia School of Law.

#### **JHH Bicentennial Scholarship Fund**

When the gifts to the Fund have met the minimum funding level of \$153,330 (at the Law School Foundation), the Fund will be considered eligible for distributions (Income). The Income of the Fund shall be used to provide scholarships to J.D. degree candidates enrolled in the Law School.

#### **Class of 1990 "Every School" Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the Curry School Foundation), the Fund will be considered eligible for distributions (Income). It is the Donors' preference that fellowships be awarded to graduate students studying in the Department of Chemical Engineering in the School of Engineering and Applied Science.

#### **Arani Family Grand Challenge Fellowship Fund**

When gifts to the Fund have met the minimum funding level of \$600,000 (at the College Foundation), the Income of the Fund shall be used to provide a perpetual series of fellowships to support graduate students in Arts & Sciences who are the strongest and most competitive students, as determined by the Dean of Arts & Sciences.

The Fellowship shall be awarded to deserving graduate students pursuing a Ph.D. in Mathematics and will support the recruitment of outstanding students.

#### **Valentine, Michael and Shannon Family Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the Med School Fdn), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide scholarships to graduate students enrolled in the School of Medicine and the Batten School, alternating each year between the Schools. During each year that the scholarship is awarded to graduate students enrolled in the School of Medicine, it is the Donor's preference that it be awarded to medical students.

#### **Burke, David C. Bicentennial Public Service Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$166,667 (at the Law School Foundation), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide scholarships to J.D. degree candidates enrolled in the Law School with a preference for students identified as prospective applicants for the Law School's program in Law and Public Service or, if such program no longer exists, otherwise demonstrating an aptitude, interest, and/or plan to enter public service careers.

If the Income cannot be used in any given year for the purpose specified here, it may be reinvested.

#### **Hugin, Robert J. USMC Scholarship Fund II Bicentennial Fund**

It is understood and agreed that the Income of the Fund will be pooled with other such resources to award scholarships for students at Darden who are members or veterans of the United States Marine Corps (USMC) or US Marine Corps Reserves. The scholarship award will be referred to as the "Darden USMC Scholarship". It

is the Donor's intent that this commitment be used as a challenge gift to help inspire others to establish endowments that support scholarships for USMC students at Darden.

#### **Darden Student Excellence Bicentennial Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide scholarships to graduate students in the Darden School of Business.

#### **Sugarman Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$166,670 (at the Law School Foundation), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide scholarships to J.D. degree candidates enrolled in the Law School. The Donor's preference is that scholarships be awarded to students who are first generation college graduates.

#### **Dahmen, Gene D. '67 Bicentennial Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$166,670 (at the Law School Foundation), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide scholarships to J.D. degree candidates enrolled in the Law School, with a preference for students who demonstrate financial need and/or students who would support the Law School's educational mission and goal of promoting a diverse student body. The Law School will review each student's qualifications on an individualized basis and consider a broad spectrum of factors such as socioeconomic status, educational background, and life experiences, consistent with the goal of obtaining the educational benefits of diversity.

#### **Lenox Family Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the Curry School Foundation), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide scholarships to graduate students enrolled in the Curry School of Education and Human Development.

Once eligible for distributions, two scholarships will be awarded annually in honor of James P. Lenox and Raymond A. Hale, respectively. It is the Donors' preference that scholarships be awarded to students who are focused on administration and supervision at the secondary/high school level at the Curry School of Education and Human Development, with strong consideration for students that are or have the intent to become high school principals, who show a strong sense of purpose, determination and work ethic, and who exude excellence and integrity in all aspects of life.

#### **Murphy, Byrne and Pamela Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the Darden Foundation), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide scholarships to graduate students enrolled in the School.

#### **Colker & Powell Bicentennial Fellowship in Classics Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the College Foundation), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide

fellowships to graduate students enrolled in the Department of Classics in Arts & Sciences. In giving this gift, it is the donor's intent to honor Marvin L. Colker, who was a professor in the Department of Classics.

#### **Davis/Offit Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the Med School Fdn), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide scholarships to M.D. degree candidates enrolled in the School of Medicine with a preference for students who demonstrate financial need and/or students who would support the Medical School's educational mission and goal of promoting a diverse student body. The School of Medicine will review each student's qualifications on an individualized basis and consider a broad spectrum of factors such as socioeconomic status, educational background, and life experiences, consistent with the goal of obtaining the educational benefits of diversity.

#### **Class of 1985 Mark A. Kaish Bicentennial Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the Darden Foundation), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide scholarships to graduate students enrolled in the School, with a preference for students with demonstrated financial need.

#### **Doumar, Robert and Noelle Darden Jefferson Fellowship Fund**

When gifts to the Fund have met the minimum funding level of \$500,000 (at the Darden Foundation), the income of the Fund shall be used to provide Jefferson Fellowships to deserving graduate students at the University of Virginia School of Business. These fellowships shall be awarded according to the established criteria and selection process of the Jefferson Scholars Foundation. Generally, selected recipients will demonstrate leadership, scholarship, and citizenship and have the potential to become extraordinary business leaders.

#### **Lozano, Mandy Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide scholarships enrolled in the School, with a preference for students who would support the School's educational mission and goal of promoting a diverse student body. The School will review each student's qualifications on an individualized basis and consider a broad spectrum of factors such as socioeconomic status, educational background, and life experiences, consistent with the goal of obtaining the educational benefits of diversity.

#### **Spencer-Horsley, Audrey Bicentennial Fellows Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the Fund will be considered eligible for distributions (Income). The Income of the Fund shall be used to provide fellowships to graduate students in the Architecture School. It is the Donors preference that fellowships be awarded by the School in accordance with the Awarding Guide criteria and process established by the School of Diversity, Equity, and Inclusion Scholarships.

#### **McCue, Frank C. III Memorial Bicentennial Fellows Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the Med School Fdn), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide fellowships to graduate physician fellows enrolled in the School of Medicine. It is the Donors' preference that fellowships be awarded to physician fellows specializing in hand and athletic surgery in the School of Medicine's Department of Orthopaedic Surgery, and that the Fund be used to support the recipient's education and research. Distribution of fellowship funds will be determined through a competitive process designed by the Chair of the Department of Orthopaedic Surgery in consultation with the Department of Orthopaedic Surgery Fellowship Training Directors.

#### **Elson, Louis G. Private Equity Scholarship Fund**

The Income of the Fund shall be used to provide scholarships for Second Year graduate students in the School. Established by Louis G. Elson (MBA '90) in 2018, The Louis G. Elson Private Equity Scholarship acknowledges the member of the student body who best exemplifies spirit and excellence in the study and practice of private equity, including contributions to the Darden Private Equity Club's activities. The scholarship honors the history

of investors who have graduated from Darden and recognizes a Second Year student for exceptional leadership and contributions to the pursuit of private equity careers and ties to practice in the curriculum. The scholarship will be awarded annually in the spring term in consultation with the faculty members most involved in the private equity course's instruction and the Mayo Center for Asset Management leadership team. The recipient of the scholarship may be awarded the entire distribution from the Fund available in that given year.

#### **Class of 1991 Memorial Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the Med School Fdn), the Fund will be considered eligible for distributions (Income). The Income of the Fund shall be used to provide scholarships to MD degree candidates enrolled in the School of Medicine.

#### **Johnson, Timothy Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the Med School Fdn), the Fund will be considered eligible for distributions (Income). The income of the Fund shall be used to provide scholarships to M.D. degree candidates enrolled in the School of Medicine who demonstrate financial need. It is the donor's preference that scholarships be awarded to students pursuing an international elective with the Center for Global Health. The Donor requests that the aforementioned use of the Fund be determined by the Dean of the School of Medicine or his/her designee.

#### **Barnett, Edward Wayne Bicentennial Fellows Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the Fund will be considered eligible for distributions (Income). The Income of the Fund shall be used to provide fellowships to graduate students in the Architecture School. It is the Donors' preference that fellowships be awarded by the School in accordance with the Awarding Guide criteria and process established by the School of Diversity, Equity, and Inclusion Scholarships.

#### **Russell, Mary and Lillie Brown Memorial Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the Med School Fdn), the Fund will be considered eligible for distributions (Income). The Income of the Fund shall be used to provide scholarships to M.D. degree candidates enrolled in the School of Medicine with a preference for students who demonstrate financial need and/or students from underrepresented populations. The School of Medicine will define 'underrepresented' to include a broad spectrum of students from backgrounds that currently lag behind in access to medical education.

#### **Coleman, Timothy and Deborah Medical Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the Med School Fdn), the Fund will be considered eligible for distributions (Income). The income of the Fund shall be used to provide scholarships to M.D. degree candidates enrolled in the School of Medicine.

#### **Hostetler-Sudduth Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the UVA Health Fdn), the Fund will be considered eligible for distributions (Income). The income of the Fund shall be used to provide scholarships to M.D. degree candidates enrolled in the School of Medicine, with a preference for students who demonstrate financial need.

#### **Wood/Nash Legacy Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the Med School Fdn), the Fund will be considered eligible for distributions (Income). The Income of the Fund shall be used to provide scholarships to M.D. degree candidates enrolled in the School of Medicine with a preference for students who demonstrate financial need and/or students from underrepresented populations. The School of Medicine will define 'underrepresented' to include a broad spectrum of students from backgrounds that currently lag behind in access to medical education.

#### **Parente, Sharon and John Risner Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the Curry School Foundation), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide scholarships to graduate students enrolled in the School. It is the Donors' preference that scholarships be awarded to students participating in a STEM discipline within the School.

#### **Mead Family Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide scholarships to graduate students in the Darden School of Business. It is the Donor's preference that scholarship be awarded to students with demonstrated financial need.

#### **Brown, Carlos M. '99 and Tamara A. Charity-Brown, M.D., Bicentennial Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$166,667 (at the Law School Foundation), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide scholarships to J.D. degree candidates enrolled in the Law School, with a preference for students from "underrepresented populations" who demonstrate financial need and/or students who would support the Law School's educational mission and goal of promoting a diverse student body. The Law School will define "underrepresented" to include a broad spectrum of students from backgrounds that currently lag behind in access to legal education and/or representation in the legal profession or the Law School student body.

#### **Galaria, Noreen and Irfan Bicentennial Fellowship Fund in Islamic Studies**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the College Foundation), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide support to students pursuing graduate research in the socio-historical and political dimensions of Islamic Studies in Arts & Sciences, at the discretion of the Dean of Arts & Sciences. The Income may support students pursuing research in Islamic Studies in the humanities or in the social sciences.

#### **Freeland, James R. and Laurence C. Franklin Endowed Fellowship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the Fund will be considered eligible for distributions ("Income"). Together with the matching funds, and assuming reasonable performance of the endowment, the hope is to deliver annual scholarship support of \$10,000 or more. The Income of the Fund shall be used to provide need-based scholarships to graduate students that have been admitted to the School based on their merit as part of the Access Darden Scholarship Program. It is the Donor's wish that there be a new Awardee each year, and thus that there be a distribution of most if not all of the Income each year (rounded down to the nearest \$1,000). See #9 of Gift Agreement for eligibility requirements.

#### **Daniel Family Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$500,000 (at the Darden Foundation), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide half-tuition scholarships to graduate students in the School in accordance with the Awarding Guide criteria and process. It is the Donor's preference that scholarships be awarded to Second Year students who were in the top third of the First Year class after their semester at Darden School; with an additional preference for students pursuing a general management career and with an interest in one or more of the following academic areas; leadership; lean thinking and kaizen; technology & operations management. A selection committee that involves Darden staff or technology & operations management faculty shall review and select the nominees. Financial need is a factor for consideration, but not a requirement for application. Awards shall be made during the spring of the first year of academic studies, or at the discretion of the financial aid office.

#### **India Studies Bicentennial Scholars Fund**

When gifts to the Fund have met the minimum funding level of \$100,000, the Fund will be considered eligible for distributions (Income). The Income of the Fund shall be used to provide scholarships to undergraduate and/or graduate students at the University. It is the Donors' preference that scholarships be awarded to students who are studying in the India Program and pursuing and international experience through UVA, such as study abroad, research abroad, or global internship. Recipients shall be selected by the School in coordination with the International Studies Office.

**Professor William W. Sihler Bicentennial Scholarship Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the Darden Foundation), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide need-based scholarships to graduate students at the School as part of the Access Darden scholarship program.

When gifts to the Fund have met the minimum funding level of \$100,000, the Fund will be eligible for distributions ("Income"). The University Achievement Award supports students from the Commonwealth who demonstrate academic merit, leadership, and outstanding citizenship. ### **Piedmont Virginia Community College University Achievement Award Fund**

The Income of the Fund shall be used to provide scholarships to undergraduate students transferring from Piedmont Virginia Community College to UVA and who have been selected as recipients of the University Achievement Award. The University Achievement Award supports students from the Commonwealth who demonstrate academic merit, leadership, and outstanding citizenship. Recipients are selected by the University's Office of Admission in coordination with Student Financial Services and in accordance with the criteria and process established for the University Achievement Award.

#### **Rudolph, Sid and Jane University Achievement Award Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the Engineering Fdn), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be distributed to the University's Office of Student Financial Services consistent with a mutually agreed upon schedule approved by Student Financial Services and the Foundation and used to provide scholarships to undergraduate student recipients of the University Achievement Award. The University Achievement Award supports students from the Commonwealth who demonstrate academic merit, leadership, and outstanding citizenship. Recipients are selected by the University's Office of Admissions in coordination with Student Financial Service and in accordance with the criteria and process established for the University Achievement Award.

It is the Donors' preference that scholarships be awarded to students enrolled in the School of Engineering. If one or more recipients are selected for scholarships according to the Donors' preference and there are remaining funds available, or if the Donors' preference cannot be met in any given year because no students who meet the preferred criteria can be identified, the Income may be used to provide scholarships to any recipient of the University Achievement Award.

#### **King, Kevin and Claire University Achievement Award Fund**

When gifts to the fund have met the minimum funding level of \$100,000, the Fund will eligible for distributions ("Income"). The Income of the Fund shall be used to provide scholarships to undergraduate student recipients of the University Achievement Award. The University Achievement Award supports students from the Commonwealth who demonstrate academic merit, leadership, and outstanding citizenship. Recipients are selected by the University's Office of Admission in coordination with Student Financial Services and in accordance with the criteria and process established for the University Achievement Award.

#### **McWilliams, Karen Turner University Achievement Award Fund**

When gifts to the Fund have met the minimum funding level of \$100,000 (at the Education Fdn), the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be distributed to the University's Office of Student Financial Services consistent with a mutually agreed upon schedule approved by Student Financial Services and the Foundation and used to provide scholarships to undergraduate student recipients of the University Achievement Award. The University Achievement Award supports students from the Commonwealth who demonstrate academic merit, leadership, and outstanding citizenship. Recipients are selected by the University's Office of Admissions in coordination with Student Financial Service and in accordance with the criteria and process established for the University Achievement Award including. It is the Donors' preference that scholarships be awarded to students enrolled in the School of Engineering.

It is the Donor's preference that scholarships be awarded to students who is enrolled in the School of Nursing.

When gifts to the Fund have met the minimum funding level of \$100,000, the Fund will be considered eligible for distributions ("Income"). The Income of the Fund shall be used to provide scholarships to undergraduate students selected into the Blue Ridge Scholars program.
